Intshayelelo

Izicwangciso sentlalo nabasebenzi zezinye zeendlela nje zepalamente yethu zokuzama ukujongana nembali ende yaseMzantsi Afrika yokungalingani kwicandelo lemigodi. UMthetho wamaCebo oPhuhliso lweziMbiwa nePetroleum (Mineral and Petroleum Resources Development Act) (okanye i-MPRDA) uthi amacebo ezimbiwa zelizwe ngamafa aqhelekileyo abo bonke abaphila apha. Umsebenzi wombuso kukongamela indlela la macebo asetyenziswa ngayo nokuqinisekisa ukuba oku kuyinzozo kubo bonke abantu. Oku kuthetha ukuba kusegunyaeni lombuso, ngokukodwa iSebe lamaCebo eziMbiwa, ukulawula amalungelo okumbiwa kwemigodi.

NgokoMthetho we-MPRDA, ukuba kukho umgodi kufuphi nomzi wenu, ngako oko kufuneka wenze umnikelo kuphuhliso lomzi. Nasiphi isicelo sokumba umgodi kufuneka siquke isicwangciso sentlalo nabasebenzi (okanye i-SLP) ukuchaza ukuba isicwangciso somgodi siya kuba luncedo njani kwimizi. Injongo ye-SLP kukukhuthaza ingqesho, ukuphucula intlalo nentlalontle yoqoqosho, ukunikela kutshintsho lweshishini lemigodi nokuqinisekisa ukuba iinkampani zemigodi zinikela kuphuhliso lwemimandla ezisebenza kuyo.

Nangona kukho imithetho engqingqwa esebenzayo, inyaniso ye yokuba inkqubo ye-SLP seyingene entsebenzweni ithuba leminyaka engaphezulu kweli-12 kodwa uninzi lwemizi echatshazelwa yimigodi isephantsi kwentlupheko eqqithisileyo. Oku ngokwenxeny kungenxa yokuba ii-SLP zidla ngokuyilwa ngaphandle kokubonisana nabantu abafanele ukungcamla kuzo, ngako oko kunokwenzeka zingabinakho ukusabela kwimicel'mingeni abantu abadibana nayo kwimizi. Kananjalo ngokwenxeny kungenxa yokuba asiyiyo yonke into ethenjiswa yi-SLP enakho ukunikelwa, yaye iSebe lamaCebo eziMbiwa alilandeli ngamaxhesha onke ukuhlolra ukuba ezi zithembiso ziyafezekiswa. Oku kuthetha ukuba imizi echaphazelekayo nabasebenzi bemigodi bahlala bekwimeko yezentlalo neyoqoqosho engalunganga. Sifuna intshukumo engxamisekileyo yendlela eziyilwa ngayo ii-SLP nezifikawa ngayo entsebenzweni ukufikelela ubulungisa bezentlalo.

Injongo yesi siXhobo sokuSebenza (i-Toolkit) kukubonelela abasebenzi bemigodi nemizi echatshazelwa yimigodi ngolwazi abaludingayo ukuqonda inkqubo yentlalo nabasebenzi, ukuhlahlela i-SLP ngokuhlabo amadlala, nokuthatha inxaxheba ngokubeka iso nokuba umgodi uthobela izibophelelo zavo. IsiXhobo sokuSebenza singanceda ekucwangciseni indlela yokubophelela iinkampani zemigodi norhulumente ukudlala indima ebonakalayo ekuqinisekiseni ukuba iinkampani zenza into efunwa ngumthetho ngokweemfanelo zee-SLP zazo. IsiXhobo sokuSebenza sahlulwe ukuba zizahlulo ezintathu. Isahlulo 1 sijongene nokuthi kufakelwe ntoni kuyilo lwe-SLP. Isahlulo 2 sichaza ukuba kuqukwe bani kwinkqubo ye-SLP nendlela ongabandakanyeka ngayo. Isahlulo 3 sibonelela ngesikhkhelo sendlela yokufikelela kwi-SLP, indlela yokuyihlaluty nendlela yokusebenzia olu lwazi ukulandela umkhondo wokubona nokuba umgodi uthobela izibophelelo zavo. Idayagram ekwiphepha elilandelayo ibonisa imigangatho ehlukileyo yomsebenzi womgodi nokuthi inxulumana njani nenqubo yesicwangciso sentlalo nabasebenzi.

UMGODIUYAFIKA

Xa inkampani yokumba umgodi ifuna ukumba umgodi, kufuneka:

- Yenze isicelo kwiSebe lamaCebo eziMbiwa malunga nelungelo lokumba kanye neenkukacha eziphathelele kwifuthe lomgodi kokusingqongileyo
- Iyile yaye iquke kwisicelo sayo isicwangciso sentlalo nabasebenzi esicacisa indlela umgodi uya kuba luncedo ngayo kwimizi ngomsebenzi wokumba
- Icebisane nemizi malunga nesicelo sayo


- Izalisekise izithembiso ezenziweyo kwisicwangciso sentlalo nabasebenzi

UMGODIUYAVALA OKANYEUYANCIPHISA

Xa umgodi uvala okanye unciphisa umsebenzi, oku ayikuko ukuphela kwamaxanduva omgodi kubasebenzi bawo okanye kwimizi ekufuphi. Ngeli lixa, inkampani yokumba kufuneka:

- Izalisekise zonke izibophelelo zayo ze-SLP, idale uqoqosho oluqhube kayo kumzi nokubonelela ngezakhono kubasebenzi bayo
- Iqalise ukuhlaziya umhlaba apho ukumba bekusenzeka khona ukuze ukwazi ukusetyenziselwa ulimo



Isahlulo 1

SIYINTONIISICWANGCISO SENTLALONABASEBENZI?

Isicwangciso sentlalo nabasebenzi luxwebhu elo iinkampani zemigodi kufuneka ziluthumele kwiSebe lamaCebo eziMbiwa njengenxalenye yezicelo zazo zamalungelo okumba. Ngokwesiseko yingqokelelo yezithembiso ezenziwa ngumgodi eziba zizibophelelo ezesemthethweni sakuba samkelwe isicelo lisebe le-DMR. I-SLP imisela ngokubini into eya kwensiwa yinkampani kwimizi nabasebenzi kwakunye nendlela nexesha inkampani iya kwenza oku.

Ukwenza umzekelo, inkampani ingazinikela ngokubonelela ngezikolo lenkonzo yomzi. I-SLP iya kunika iinkcukacha zalapho inkampani izimisele ukwakha iziko, iinkonzo eziya kufumaneka kwiziko, ubungakanani bemali eya kubekwa bucala yinkampani malunga nokwakha, ixesha elo zicwangcise ukuqualisa ukwakha iziko nexesha zizimisele ukuligqiba ngalo.

Ngokufunda ii-SLP zazo, ungfumana ukuqonda okungcono ngento inkampani ezbophelele ngayo emthethweni. Ngako oko unendima ebalulekileyo ekufuneka uyenze ngenxa yokuba, njengelungu lomzi, ungaxela nokuba iziko lomzi liyakhiwa okanye hayi. Ngaphandle kokuba iluluuhlu lwezicwangciso, i-SLP kananjalo yimvumelano phakathi kwenkampani noluntu. Ukuba inkampani ayigcini izithembiso zayo, umzi ungasondela kwisabe le-DMR ngesikhala. Ngokuphathelele kulwazi olongezelewyo malunga nendlela yokubeka iso ukuthotyelwa kwee-SLP, jonga kwiSahlulo 3.

YINTONIEKUFUNEKA IQUKWEKWISICWANGCISO SENTLALONABASEBENZI?

Imimiselo ye-MPRDA imisela ngokukhethekileyo ukuba i-SLP kufuneka iquke amacandelo aliqela. La macandelo achaziwe ngezantsi.

① INKQUBO YENGINGQI YOPHUHLISO LOQOQOSHO

Icandelo lengingqi lophuhliso loqoqosho lee-SLP liyilwe ukuqinisekisa ukuba ukumba umgodi kunikela ngophuhliso lwemizi kwiindawo apha ukumba umgodi kwenzeka khona, kwakunye neendawo apha abembi-migodi bagaywa khona. Kweli candelo le-SLP, uya kufumana elona nani liphezulu leenkqubo ezikhoyo zokunceda uluntu ngokubanzi. Ezimbini zezona nkqubo zibaluleke kakhulu zibandakanya uphuhliso lwezibonelelo zokusebenza nokutshabalalisa ubuhlwempu.

Amalinge okutshabalalisa ubuhlwempu okanye ukudala ingeniso abhekisa kwinkxaso yeenkampani zemigodi ngenjongo yokunikela ngamashishini kuluntu. Oku kungaqua ubonelelo ngengxowa-mali, inkxaso yezobuchwepheshe

noqequesho. Zonke iinkqubo zezibonelelo zokusebenza nezokutshabalalisa ubuhlwempu kufuneka zilungelelaniswe nesiCwangciso sokuDibanisa uPhuhliso (Integrated Development Plan) esikhoyo kwinkqubo ajolise kuyo umasipala. Imimiselo ye-MPRDA imisela ukuba oku kufuneka kuquke:

a)	limeko zentlalo noqoqosho kummandla apha umgodi usebenza khona nemizi apha abembi-migodi bagaywa khona
b)	Imisebenzi engundoqo yoqoqosho apha umgodi usebenza khona nemizi apha abasebenzi begaywa khona (efana nolimo, ukhenketho okanye inkqubo yolungiso lokuty)
c)	Impembelelo leyo umgodi unokuba nayo kwimizi ekufuphi nomgodi nemizi apha abasebenzi begaywa khona (ukwenza umzekelo, ithuba lokuba abantu bafune ukumisa kwenye indawo, inani labantu abanokufika kummandla)
d)	Amalinge ezbonelelo zokusebenza nokutshabalalisa ubuhlwempu axhaswa ngumgodi ngokuhambelana nesiCwangciso sokuDibanisa uPhuhliso (Integrated Development Plan) lwemimandla apha umgodi usebenza khona nemizi apha abasebenzi begaywa khona
e)	Amanyathelo okujongana nobonelelo ngezindlu neemeko zokuhlala zabembi-migodi
f)	Amanyathelo okujongana nesondlo sabembi-migodi
g)	Isicwangciso somgodi sokuqinisekisa ukuba wanelisa iinjongo zePhephalaMalungelo leMigodi(Mining Charter) malunga nokufumana iimpahla neenkonzo kwiinkampani ezo ngokwembali yoMzantsi Afrika bezingalungi. Oku kufuneka kuquke iitekeni zokufumana iimpahla, iinkonzo nezinto eziphelayo ukuvela kwezi nkampani namagama neenkukacha zezi nkampani

② INKQUBO YOPHUHLISO LWAMACEBO OLUNTU

Inkqubo yophuhliso lwamacebo oluntu kufuneka icacise ukuba izimisele ukwenza njani ukuphuhlisa izakhono zabasebenzi yaye kananjalo namalungu omzi. Oku kufuneka kuquke ngokubini izakhono eziphathhelele kukombiwa kwemigodi kwakunye nezakhono ezinokusetyenziswa kwamanye amacandelo (ezi zaziwa njengezakhono eziphathwayo). Lintloblo zamalinge anokufunyanwa kweli candelo aquka imfundu nengqequesho yesiseko yabadala, uqequesho lobugcisa, amathuba okufundela umsebenzi, iinkxaso-mali zokufunda nezinye iinkuthalo zoqequesho ukwenzela abantu kumzi. Imimiselo ye-MPRDA imisela ukuba oku kufuneka kuquke:

a)	Isicwangciso sophuhliso lwezakhono zabo bonke abasebenzi. Esi sicwangciso kufuneka simisele inani labasebenzi kwakunye nomphakamo wezakhono zabo. Kananjalo kufuneka sibonelele 'ngokuzalisa izithuba ekunzima ukuzinalisa' ekuzizithuba ezo inkampani ingakwazanga ukuzinalisa kwithuba leenyanga ezili-12
b)	Isicwangciso sokuqhube ka kwenkonzo apho isicwangciso siqinisekisa abasebenzi ukuba banokwazi ukuqhube ka ukuya kwizikhundla eziphezulu
c)	Isicwangciso sobucebisi apho abasebenzi bedityaniswa ngambini nabacebisi ukuqinisekisa ukuba bangacwangcisel inkqubela yeenkonzo zabo
d)	linkcukacha-manani zobulungisa zomgodi zengqesho, kwakunye nesicwangciso somgodi sokuqinisekisa ukuba i-10% yabantu abathatha inxaxheba ekumbiweni kwemigodi ngabasetyhini, yaye ama-40% ezikhundla zolawulo ziphethwe ngabo bebefudula behlelelekile ngokwembali yabemi boMzantsi Afrika kwithuba leminyaka emi-5 ukusuka xa ilungelo lokumba umgodi linikelwa

③ UKULAWULA UKUNCIPHISA NOKUDENDA

Imimiselo ye-MPRDA imisela ukuba eli candelo kufuneka liuke:

a)	Izicwangciso zokulondoloza imisebenzi nokuphepha iilahleko zemisebenzi nokwehla kwengqesho
b)	Izicwangciso nokunikela ngezinye izisombululo neenkubo zokudala ukhuseleko lomsebenzi apho iilahleko zemisebenzi zingenakho ukuphetshwa
c)	Izicwangciso zokunciphisa ifuthe lentlalo noqoqosho kabantu, imimandla namaqoqosho engingqi apho ukudenda nokuvala umgodi kuqinisekile

④ UBONELELO LWEZEMALI

Kufuneka i-SLP ichaze izixamali ezenzelwe uhlahlo-lwabiwo lwemali malunga namacandelo alandelayo:

a)	Inkqubo yophuhliso lwamacebo oluntu
b)	Inkqubo yophuhliso loqoqosho lwengingqi
c)	Inkqubo yokulawula unciphiso nokudenda

Isahlulo 2

UNGABANDAKANYEKA NJANI?

Isakhelo somthetho asicacisi ngokucacileyo ukuba abasebenzi nemizi ingabandakanyeka nini yaye nini kuyilo nophumezo lwasicwangciso sentlalo nabasebenzi. Esi sesinye sezizathu zokuba kutheni abasebenzi nemizi echatshazelwa ngumgodi bedla ngokubekelwa bucala ekuthatheni inxaxheba kwinkqubo ye-SLP. Kodwa, ungabandakanyeka ngokukhutheleyo kwinkqubo kwiindawo zenani elihlukileyo.

I-SLP inomjikelo wobomi weminyaka emihlanu, emva koko inkampani yomgodi kufuneka inikele ngesitsha. Indawo yokuqala kule nkqubo yeminyaka emihlanu xa unakho ukubandakanyeka kukwisigaba sokuqala phambi kokuba kuthunyelwe isicelo selungelo lokumba umgodi sithunyelwe kwisebe le-DMR. Kwesi sigaba, inkampani yomgodi isekwinkqubo yokuyila i-SLP yaye kufuneka ibonisane nemizi malunga nesicelo sabo.

Indawo yesibini apho ungathatha inxaxheba kusemva kokuba ilungelo linikelwe. Usenokucela ufilelelo kwi-SLP ukuze ubeke iso nokuba inkampani yomgodi ithobela izithembiso zayo. Okokugqibela, ungasebenzisa kananjalo ulwazi lwakho lwe-SLP nolwazi malunga nerekhodi yokuthobel a kwenkampani yomgodi xa kuyilwa i-SLP entsha. Oku kwenzeka ekupheleni kwexesha leminyaka emihlanu, okanye xa inkampani yomgodi isenza isicelo kwi-DMR ukulungisa i-SLP yayo yangoku.

YINTONIINKQUBO YOLUNTU YOKUTHATHA INXAXHEBA?

Izikhokelo ze-SLP zithi iinkampani zemigodi kufuneka zicebisane noluntu phambi kokugqiba ii-SLP zazo. Kodwa, izikhokelo azinalo ilungelo lomthetho elifanayo njengoko i-MPRDA nemiselo ingathethi nto ngalo mba. Ngenxa yesi sizathu, iinkampani zomgodi azilandeli ngamaxa onke izikhokelo yaye azicebisani ngqq nemizi ngee-SLP zazo.

Nangona kunjalo, xa iinkampani zisenza isicelo selungelo lokumba umgodi, kufuneka ngokwe-MPRDA zicebisane nemizi echaphazelekayo malunga nesicelo sisonke (nangona ukucebisana ngee-SLP kungaxelwanga ngokukhethekileyo). Ngethuba lenkqubo yokuthatha inxaxheba koluntu malunga nelungelo lokumba umgodi, imizi ingacela amathuba ahlukileyo okucebisana malunga ne-SLP. Oku kucebisana okwahlukileyo kabalulekile ngenxa yokuba i-SLP luxwebhu olumbaxa yaye nemizi inokuba nenani lemiba yokuyiphakamisa malunga nelinge elibhalisiweyo.

KUTHENI KUFUNeka UMZI UZE KWIMBONISWANO?

I-SLP zigcina ulwazi malunga neenkubo zezicwangciso umgodi ofuna ukuziphumeza ukuba lunchedo kwimizi kummandla osebenza kuwo. Ezi nkqubo zingaqua izicwangciso zokwandisa izibonelelo zokusebenza ngenginqi, inkxaso yamashishini engingqi okanye uqequesho lwamalungu omzi. Ukuba ezi zicwangciso ziylwe kakuhe yaye zaphunyezwa, zingabumba uphuhliso kwimizi yengingqi. Imisebenzi yohlahlo-lwabiwo-mali Iwe-SLP iyahluka ngokobukhulu bomsebenzi womgodi, ngako oko ii-SLP zemigodi emikhulu zibaluleke kakhlulu kumzi. Ukuba ungabane futhe kwinto eqhubekayo kwezi SLP, unganakho ukufumana iinzuso zokwenene ozifunayo kumgodi. Malunga noludwe lwemibuzo ecetyiswa ukubuzwa kwezi mboniswano, jonga kwisiHlomelo A ekupheleni kweSixhobo sokuSebenza.

Qaphela ukuba iinkampani zemigodi aziphulaphuli ngamaxa onke kumazwi emizi yaye nomthetho awufuni ukuba imizi yamkele uyilo lwee-SLP. Kodwa ke, ukuthatha inxaxheba kwinkqubo ye-SLP kungomeleza indawo yomzi xa uthethana nenkampani yomgodi kwixesha elizayo. Ezi seshoni zinika ithuba lokufumana ulwazi olongezelweyo malunga nokusebenza komgodi. Kananjalo unga fumana ulovo lokuba inkampani iyibona njani imizi, yaye ungaba nethuba lokuqukwa kwiimboniswano zexesha elizayo. Ukuba nangeliphi ithuba unqwenela ukuzisa umcel'mngeni wezomthetho ngokuchasene nenkampani, ukuza kwakho kwezi ntlanganiso kuya kubonisa uthathe elinye nelinye ithuba ukuthethana nabo.

NGUBANI OKUFUNeka ABANDAKANYEKE KWINKQUBO?

① ISEBE LAMACEBO EZIMBIWA

I-DMR lisebe lesizwe likarhulumente ekulindelwe ukuba lisebenzise yaye linyanzelise imithetho enjogene nemigodi, kuquka ukndlala indima ebalulekileyo yokongamela inkqubo ye-SLP. Xa inkampani isenza isicelo sokumba umgodi, i-DMR kufuneka ithathe isiqqibo nokuba isicelo kufuneka samkelwe ngokusekelwe kwinani lamaxwebhu naqua i-SLP. Umphathi wommandla wendawo aphi inkampani ifuna ukumba umgodi uhlola esi sicelo yaye avavanye i-SLP yabo. Kufuneka ngako bazise inkampani ukuba bayayamkela i-SLP yaye ukuba abayamkeli bachaze iinguqu ekufuneka zensiwe yinkampani kwisicelo sabo. Umphathi wommandla kufuneka athumele i-SLP kuMphathiswa wamaCebo eziMbiwa, oya kunika inkampani isiqqibo sakhe sokuggibela malunga nesicelo sokumba umgodi. Kufuneka kananjalo i-DMR ibone ukuthi uluntu linakho ukuthatha inxaxheba kwinkqubo yesicelo sokumba umgodi. Xeshikweni umthetho ungakutsho ngqo oku, kufuneka imizi imenywe ukuthatha inxaxheba kwinkqubo ye-SLP.

I-DMR kananjalo inoxanduva lokubeka iso nokuba iinkampani zemigodi zithobela i-MPRDA nokuphumeza izithembiso ezenziwe kwii-SLP zazo. ISebe lihlola isiCwangciso soNyaka sokuPhumeza i-SLP kwakunye neengxelo zazo zonyaka nokuthi zithobela njani izibophelelo zazo. I-DMR kananjalo inakho ukuqhuba iimvavanyo kwisia ukuhlola umgodi yaye ukuba lifumana ukuba

umgodi awuthobel i-SLP yawo, i-DMR ingasebenzisa amandla alo okunyanzelisa. ISebe linenani lezinto zokhetho, ukusuka ekunikeleni ngesaziso kwiinkampani nokuya ekuxhomeni okanye ekucimeni amalungelo okumba umgodi, nangona oku kungaxhaphakanga. I-DMR idinga ukwahlulelana nabanye, ngokusebenzisa amaqonga exesha elizayo neminye imibutho emiselwe ukuqinisekisa ukuba ii-SLP ziyaphunyeza.

② URHULUMENTE WEZEKHAYA

Oomasipala bezekhaya nabesithili banendima ebalulekileyo abafanele ukuyiphumeza kwinkqubo ye-SLP. Umasipala ngamnye unikwe indima yokuyila isicwangciso sophuhliso esidityanelweyo (okanye i-IDP), enenjongo yesisicwangciso esiqukayo nesobuchule malunga nophuhliso lomasipala. Ezi zicwangciso zidwelisa imisebenziyokuqala kamasipala yaye iinkqubo ezizichazayo kufuneka zibonise iintswelo zemizi eziyikhonzayo. Ngako oko, kubalulekile ukuba imizi ithathe inxaxheba xa ezi zigcwangciso zipuhhliswa. Ukuqinisekisa ukuba oku kuyenzeka, kufuneka oomasipala baseke amaqonga ophuhliso loqoqosho lwasekhaya (okanye ii-LED) apho wonke ubani onomda enokubakhona ukuza kwabelana ngezimvo nangamacebo. Oomasipala kufuneka bakhuthaze imizi namaqela oluntu ukuthatha inxaxheba kula maqonga, yaye kananjalo kufuneka athethathethane nemigodi ukuze ii-SLP zayo zibenakho ukuthathela ingqalelo izicwangciso zophuhliso ezidityanelweyo namalinge.

Xeshikweni kungekho indima esesikweni yokuba urhulumente wezekhaya adlale indima yokubeka iso kwindlela umgodi uthobela ngayo i-SLP yawo, angancedisa i-DMR kakhulu ngale ndlela. Ngenxa yokuba banolwazi lwezekhaya, oomasipala basethubeneli hlelo lokuhlolola nokuba izithembiso ezenziweyo kwi-SLP ziyagcinwa yaye ngokukhethekileyo ukuba umgodi usebenza kumalinge ophuhliso loqoqosho lwezekhaya.

③ IINKAMPANI ZEMIGODI

Inkampani zemigodi kufunwa ukuba ziyle yaye ziphumeze iinkqubo zokuqinisekisa ukuba ubutyebi bezimbiwa busetyenziselwa upuhliso lwemizi nabasebenzi. Njengoko sibonile, kufuneka ziyle yaye zithumele i-SLP njengenxalenye yesicelo sokumba umgodi. Kananjalo kufunwa ngokomthetho ukuba zinikele kuzo zonke izithembiso ezizenzileyo kwii-SLP zazo emva kokuba zivuniyi. Inkampani yomgodi ngako oko kufuneka ibonelele ngeengxelo ngendlela yokunikela ezi zithembiso ngendlela yeengxelo zonyaka nezicwangciso zokuphumeza ezithunyelwe kwiSebe lamaCebo eziMbiwa.

Ukuba inkampani inqwenela ukwenza naziphi iinguqu kwiinkqubo ezidweliswe kwi-SLP yayo, ingenza njalo kuphela ngemvume yoMphathiswa wamaCebo eziMbiwa. Kubalulekile ukuba imizi nabasebenzi babenendima ebalulekileyo kwizigqibo eziphathhelele kwezi nguqu ukuqinisekisa ukuba iinkampani zemigodi azisebenzisi le nkqubo ukunciphisa izibophelelo zazo. Umgodi, urhulumente nemizi kufuneka babonisane ngalo lonke ixesha lobomi bomjikelo we-SLP. Kukho isakhelo esikhokhela imigodi ngokubonisana nemizi echaphazelwa kukombiwa komgodi, ezibizwa isiKhokhelo sokuBonisana neMizi (Guideline for Consultation with Communities) kwakunye namaQela anoMdla aChaphazelekayo. Kodwa ke,

oku akuchazi imigodi kufuneka iquke imizi nini okanye njani kwinkqubo ye-SLP ngokukhethekileyo.

Imimandla enobutyebi bezimbiwa iya kusoloko ihlinzeka amalinge amaninzi ahlukeneyo neenkampani. limpembelelo zokusingqongileyo, ezentlalo nezoqoqosho zomgodi ziya kuvakala kuwo wonke ummandla yaye ngamanye amaxesha kuya kubanzima ukulandela umkhondo kumgodi omnye okanye ilinge. Ukuba ayikho inzame yokudibania ii-SLP zeenkampani, kukho ithuba elongezelelwego lokuba abantu kweminye imizi ekufuphi nomgodi baya kushiywa ngaphandle kwinkqubo ye-SLP yaye banokungaziboni iinzuso zee-SLP. linkampani zemigodi ezikwindawo efanayo kufuneka zisebenze kunye yaye kufuneka urhulumente aqinisekise ukuba oku kuyenzeka. Sifumanisile phofu ukuba kukho ukhuphiswano oluninzi, ihlebo nokucingela phakathi kwemizi yemigodi emikhulu nakweminye imigodi emitsha, yaye idla ngokungasebenzisani ngempumelelo.

④ IMIZI

Kwakunye nabasebenzi bomgodi, abaxhamli abangundoqo benkqubo ye-SLP kulindeleke kube yimizi yabo abahlala apho ukumbiwa kwenzeka khona. Kukho kananjalo eminye imizi ekude nomgodi echatshazelwayo kananjalo ngumgodi ngenxa yokuba uninzi lwabasebenzi bomgodi kufuneka behambile ukusuka kwezi ndawo ukufumana umsebenzi. Le mizi, ikakhulu eMpuma Kapa okanye Kwa-Zulu Natala, kufuneka nayo iqukwe kubaxhamli bee-SLP.

Imizi iyachaphazeleka ziimpembelelo ezimbi zemigodi yaye kufuneka ibuyekezwu ngenxa yoku. Ukufumana ubulungisa kwicandelo lemigodi, kufuneka imizi ifumane iinzuso ezongezelelwego kwimigodi kunokufumana imenzakalo. Izicwangciso zentlalo nabasebenzi kunye nezicwangciso zophuhliso oludityanelwego kufuneka zisekelwe phezu kweentswelo zokwenene ezivakaliswa yimizi. linkampani zemigodi norhulumente wezekhaya kufuneka zibandakanye imizi ekwenzeni ezi zicwangciso, yaye kananjalo ekubekeni iso amalinge nokuxoxa nangaziphi iinguqu kwizicwangciso.

Ngelishwa, kwimizi esisebenze kuyo, imigodi noomasipala badla ngokubonisana kuphela neqela elincinci lamalungu omzi. Uninzi lwabantu kumzi abazange babone okanye beve malunga ne-SLP. Kubalulekile ukuba imibutho yemizi yazi ngamalungelo ayo phantsi kwe-MPRDA kwakunye nenqubo ye-SLP. Apho imizi yahlukeneyo, iinkampani norhulumente kufuneka bathethane nawo onke amacandelo ahlukeneyo omzi.

⑤ IZIPHATHAMANDLA ZEMVELI

Iziphathamandla zemveli zidlala indima ebalulekileyo xa ukumba umgodi kusenzeka kumhlaba womzi. Ngala maxesha kungakho impixano phakathi kwezipathamandla zemveli namalungu omzi. Oku kungenxa yokuba kuba sisiqhelo nangakumbi ukuba inkoheli zemveli zigcine amanye amalungu omzi engazi xa kusensiwa uthethathethano lwezivumelwano neenkampani zemigodi ukusebenzisa umhlaba womzi. Imizi ukujikeleza ilizwe ixela ukuba

ezi zivumelwano zixhamlisa ikakhulu iinkokheli zemveli kunomzi ngokubanzi, kwanokususa amalungu omzi kumhlaba. Kananjalo abekhona amaxesha xa imizi ixele ukuba iinzuzo ze-SLP, eziquka iibhazari ezenzelwe injongo yokuxhasa amashishini omzi, zisiya kwinkokheli zemveli neentsapho zazo kunokuya kwabo bazidunga ngokwenene. Oku kudala imeko engazinzanga apha imizi ehlala ngentlupheko ibona ubutyebi buphala kuphela ukuya kwiinkokheli zemveli nenkampani yomgodi.

⑥ IIMANYANO ZABASEBENZI

limanyano zimele abembi bemigodi, abayinxalenye yemizi yemigodi yaye kufuneka nabo kananjalo babe ngabaxhamli abangundoqo benkqubo ye-SLP. limanyano ezifana ne-National Union of Mine workers (NUM) kune ne-Association of Mine workers and Construction Union (AMCU) banakho ukuvakalisa iinkxalabo neentswelo zamalungu azo. Nazo kananjalo zidlala indima ebalulekileyo ekuyleni ii-SLP, nasekubekeni iso kwindlela imigodi ithobela ngayo izibophelelo zayo zokuxhamlisa abasebenzi, ukwenza umzekelo, ngophuhliso lwezakhono zabo nolwakhiwo lwezindlu. Abameli babasebenzi kananjalo bahlala kwiqonga lexesha elizayo eliceba iziphumo zokuvalwa komgodi okanye ukuncitshiswa kwabasebenzi.

⑦ ABANINIKONTRAKI BEMIGODI

Abembi migodi abaninzi abaqueshwanga ngqo yinkampani yomgodi, kodwa baqweshe ziikontraki. Abasebenzi bekontraki kufuneka baxhamle ngokufanayo nabasebenzi abasisigxina njengoko benegalelo kumgodi. Kodwa, ngokuqhelekileyo, abasebenzi bekontraki abadli ngokonwabela iinzuzo zenqubo ye-SLP.

Umhetho ucacile: iinkampani zomgodi azinakho ukubaleka kwizibophelelo zazo ze-SLP ngokuquesha abasebenzi bekontraki ukwenza umsebenzi. Kodwa ayikho into yokulawula indlela iinkampani zemigodi nabaninikontraki bazo kufuneka basebenze kune ukuphumeza ii-SLP. Unikelo kwiKhomishini yoPhando yaseMarikana ngumcebisi luthi iinkampani zemigodi ezahlukileyo zahluke kakhulu kwindlela yazo kubaninikontraki. Icandelo lemigodi alinayo indlela ezinzileyo yokufaka abaninikontraki kwinkqubo ye-SLP.

Isahlulo 3

SINGAFIKELELA NJANI KWI-SLP?

Ukuba awuyonxalenyen yenkubo ye-SLP kwa ukusuka ekuqaleni, usenakho ukudlala indima ebalulekileyo ekuhlahleleni uxwebhu nokunceda ukuqinisekisa ukuba umgodi uayithobela. Kuqala, kuya kufuneka ufikelele kwi-SLP. Ngenxa yokuba ii-SLP ngamaxwebhu oluntu yaye injongo kukuxhamlisa imizi nabasebenzi, iinkampani zemigodi neSebe laMancedo eziMbiwa kufuneka licingele ngaphambili ngokubonelela ngee-SLP yaye akufunekanga kubekho imfuneko yokuba uzicele. Inani lemibuthu igaya ukuba ii-SLP zenziwe zifumanene kuluntu ngokuzenzekela. Nangona kunjalo, ngeli lixa uninzi lwee-SLP azensiwa zifumanene kwimizi, ngako oko kubalulekile ukuba zifumanene kwimizi, ngako oko kubalulekile ukuba uyazi indlela ongacela ukufikelela ngayo kuzo. likopi zee-SLP zigcinwa ngokubini yi-DMR nenkampani yomgodi ongasondela komnye wazo ukucela ukufikelela.

① ISICELO SOFIKELELO ESIVELA KWI-DMR

ISebe laMacebo eziMbiwa kufuneka libeneerekhodi zazo zonke ii-SLP zeenkampani. Ukuze ubenakho ukufikelela iirekhodi ezivela kwi-DMR, kufuneka ulandele inkubo emiselwe kumthetho we-Promotion of Access to Information Act (owaziwa njenge-PAIA). Kule meko, kuya kufuneka uzalise ifomu ebizwa i-DMR 131 Request of Access to Records uze unikele le fomu kwi-DMR ePitoli. Ungayifumana ikopi yale fomu ekupheleni kwesiXhobo sokuSebenza kwisiHlomelo B. uya kufumana impendulo evela kubo kwithuba leentsuku ezingama-30 mhlawumbi ekunika ufikelelo okanye elandula ufikelelo kumaxwebhu. Xa unikiwe imvume yofikelelo kumaxwebhu, ungathunyelwa kwiofisi yasekhaya ye-DMR apho ungenza ikopi ye-SLP. Ukuba awunikelwanga ufikelelo, ungenza isibheno sesi sigqibo ngaphakathi kwi-DMR.

② CELA UFIKELELO KWINKAMPANI YEMIGODI

Kumava ethu, kulula ukufikelela ii-SLP ukuvela kwi-DMR, kodwa kananjalo ungasondela kwiinkampani zemigodi ngokwazo. Isicelo kwinkampani singenziwa ngokungekho sikweni, kodwa ezi zicelo zidla ngokungaphumeleli. Kananjalo unalo ukhetho kwakhona usebenzisa umthetho we-Promotion of Access to Information Act nokuzalisa ifomu yesicelo solwazi olugcinwe liqumrhu labucala. Ungafumana ikopi yale fomu yesicelo ekupheleni kwe-Toolkit (isiTshixo sokusebenza) kwisiHlomelo C. Uya kubona ukuba kufunwa ukuba ubonise ukuba uxwebhu olucelayo lufunwa ukusebenzisa okanye ukukhusela amalungelo akho. Kusekhona ingozi ephezulu yokuba isicelo siya kulandulwa. Ngokungafaniyo xa usondela kwi-DMR, awunakuba nakho ukwenza isibheno kwesi sigqibo nenkampani yemigodi yaye endaweni yoko kuya kufuneka uye enkundleni.

UNGANCEDA NJANI UKUQINISEKISA UKUBA UMGODI UTHOBELA IZIBOPHELELO ZAWO ZESICWANGCISO SENTLALONABASEBENZI?

Wakuba ufilelele kwi-SLP yomgodi kumzi wenu ungaahlalutya ngononophelo isiqulatho sesicwangciso. Inyathelo lokuqala kukufunda sonke isicwangciso ngobunzulu, ubuza imibuzo kwi-SLP yokuhlolola iimpazamo kwisihlomelo D. Oku kuya kukunceda ukufunda nokuba kukho naziphina iingxaki ngoziyo lwe-SLP. Kanjalo ungasebenzisa iitekeni ezimiselwego kwi-SLP ukubeka iso nokuba inkampani yemigodi iyanikela ngezithembiso zayo. Ungasebenzisa uluhlu, elifana nelo lifumaneka kwisihlomelo E, ukukunceda ukubeka iso nokurekhoda nokuba umgodi wanelsa iitekeni ezimiselwe kwi-SLP yawo. Ungaqlala ngokudwelisa iitekeni ezivela kwi-SLP, ezi tekeni bekulindelwe ukuba zifezekiswe nini, kwanokuthi ingaba umgodi uzifezekisile okanye hayi.

KWENZEKA NTONI UKUBA UMGODI AWUZIFEZEKISI IZIBOPHE-LELO ZAWO?

Wakuba uyikalile inkqubo yokurekhoda ukuthobela komgodi ii-SLP zaho, unaqaphela ukuba izithembiso ezenziwe ngumgodi aziphunyezwanga. Ungafumana obunye ubungqina ngokucela ufilelelo kwingxelo yonyaka yenkampani. Xa ucinga ukuba umgodi awuthobeli izibophelelo zaho ezisemthethweni, ungasondela kwiSebe laMacebo eziMbiwa (Department of Mineral Resources) ukumangalela inkampani yemigodi. Jonga izihlomelo F no-G malunga nemizekelo yeencwadi ongazisebenzisa.

Kwiimeko ezininzi, baya kuba khona abasebenzi-migodini kwimizi echaphazelekayo ngumsebenzi womgodi yaye abasebenzi banokoyika ukulahlekelwa yimisebenzi yabo xa bexela izinto zomgodi. Oku kuyaviseka ngokwenene. UmThetho woKhuselo IweziTyhilelo (Protected Disclosures Act) uthintle iinkampani ekoyikiseni okanye ekusongeleni abasebenzi malunga nokuxela ukuziphatha okuchasene nomthetho. Oku kuquka neengxelo kwi-DMR ukuba inkampani ayifezekisi izithembiso ezikwi-SLP yazo.

Izithembiso zenkampani yemigodi ezenziwa kwisicwangciso sayo sentlalo nabasebenzi siyabophelela ngokusemthethweni. Ukuba umgodi awuthobeli i-SLP, ngako i-DMR ingamisa okanye icime ilungelo labo lokumba umgodi. Nangona kunjalo, ngokuqhelekileyo amathuba okwenzeka koku anqabe kakhulu. Inxene yale ngxaki yeyokuba i-DMR njengangoku ayinabo abahloli abaneleyo bokubeka iso ukuba yonke imigodi ithobela ii-SLP zayo, enye inxene yeyokuba akukho nkuthazo ininzi yokwenza oku kubeka iso. Uxinzelelo lwamalungu omzi nabasebenzi lubalulekile njengoko ningabathathi-nxaxheba abanowona mdla mkhulu ekuboneni ukuba imigodi ithobela ii-SLP zayo.

Ngenxa yesi sizathu, uqequeso lwabahlali bemizi nabasebenzi malunga namalungelo lubaluleke kakhulu. Imibutho emininzi efana ne-Ndifuna Ukwazi ilandele ngempumelelo ukusebenza kukarhulumente yaye usebenzise olu lwazi njengesixhobo sokubanyanzelisa ukuphumeza izibophelelo zabo kwimizi. Kukho ithuba lokuba ii-SLP zisetyenziswe ngokufanayo. Ulwazi olongezelelwego olwaziyo

malunga nee-SLP, uya kubanakho ngakumbi ukuqwalasela nokurekhoda nokuba iinkampani zemigodi ziphumeza izithembiso zazo. Unganakho ke ukucela umgeni kubo uxhobe ngeenyaniso ezibhaliweyo/ ezirekhodiweyo.

Enye inkuthazo yokuba imigodi ithobele ii-SLP zayo luloyiko lokuba amagama ayo onakale. Isitshixo esiphambili sokulwela ubulungisa bezentlalo semizi nabasebenzi abachatshazelwa yimigodi kukuqaphelisa abasemagunyeni xa umgodi ungaphumezi izithembiso zawo. Wakuba uhlahlele i-SLP wafumanisa ukuba umgodi awuyithobel, ungathumela umyalezo ongqongqo wokuba iinkampani zemigodi azifezekisi izibophelelo zazo ezisemthethweni.

ZEZIPHIIZILUNGISO EZINOKUBAKHONA EZIFUMANEKAYO?

(1) UKUBEKA ISO UKUTHOBELA

Ukuba unesizathu sokukholelw uku umgodi uqhuba imisebenzi ngaphandle kogunyaziso okanye ayithobel imiqathango yeelayisensi zayo kuquka ii-SLP, ungasondela kwiSebe le-Department of Mineral Resources. Linegunya lokuphanda kwanokunyanzelisa umgodi ukuyeka imisebenzi engekho mthethweni okanye lirhoxise ilayisenzi zawo. linkcukacha zoqhagamshelwano zeSebe zingafunyanwa kwisiHlomelo C.

(2) UMANGALELWANO

Ukuba uyazi ukuba ilungelo lokumba umgodi linikelwe kodwa unqwenela ukuphikisana nesi sigqibo, unokhetho lokusa umgodi enkundleni. Umangalelwano lungaba yinkqubo yexesa elide yaye akukho siqinisekiso sokuba luya kuphumelela. Ukuthatha isiqqibo sokuya enkundleni kufuneka sithathwe kuphela emva kokusinga nokuxoxa nomzi ngononophelo. Emva koko ningaya emaggwetheni afana nalawo adweliswe kwisiHlomelo C. Umthetho wethu uvumela iindlela zokhetho eziliqela ukuze usebenzise amalungelo akho ukuba umgodi ube neempembelelo ezimbi nezingamkelekiyo kwimekobume esinqqongileyo. Le nkqubo idla ngokugala ngokufaka isibheno kuMphathiswa waMacebo eziMbiba, weMicimbi yezokuSingqongileyo okanye wezaManzi noGutuulo ngokuxhomekeke kwimo yesikhala sakho. Kubalulekile ukufaka isibheno kwithuba lamaxesha achanekileyo. Ukuba uMphathiswa ofanelekileyo uyasikhaba isibheno sakho, ngako ke ungaya kwiNkundla ePhakamileyo apho ijaji iya kuhlola isiqqibo yaye inokuyalela uMphathiswa ukucinga ngesiqqibo kwakhona.

Kananjalo kunokwenzeka ukufaka isimangalo solwaphulomthetho ngokuchasene nomgodi okanye abaphathi benkampani yomgodi. Kukho iqela lezenzo zolwaphulomthetho zokusingqongileyo eziquka ukumba imigodi ngaphandle kweemvume ezichanekileyo okanye ilayisenzi, okanye ukumba umgodi ngaphandle kommandla welungelo lokumba umgodi. Kananjalo kunokuba lityala lolwaphulomthetho ukungathobel imiqathango ye-SLP. Ukuba kukho ungciliseko olungamandla lomhlaba wakho, amanzi okanye umoya, kunokwenzeka ukuba umgodi usebenza kummandla ngokungekho mthethweni.

Olunye ukhetho olufumanekayo kukufaka ibango lezentlalo. Ukuba ubandezeleke ngokomzimba okanye okunye ukwenzakala yaye ungabonisa ukuba oku kuvela kungcoliseko oludalwa ngumgodi, ungabanga iimonakalo ngokuchasene nomgodi. Kubalulekile ukuqaphela ukuba la mabango angaphumelela kuphela ukuba ungabonisa ukuba uvelelwwe yingozi, ukuba umgodi usebenze ngokuphosakeleyo, kwanokuthi ukwenzakala okufumeneyo kube sisiphumo seli nyathelo eliphosakeleyo. Uya kudinga uncedo lwengcali ukubonisa inkundla ukuba le ngozi idalwe ngumgodi.

ISIGQIBO

Njengoko sibonile, umthetho ngoku ufunu iinkampani zemigodi zipuhhlise izicwangciso zentlalo nabasebenzi ukuba yinzozo kwimizi njengenxenyi yesicelo nasiphi samalungelo okumba umgodi. Nangona kukho le mithetho esebezayeo, inkqubo ye-SLP isilele kakhlulu ekuphumezeni izithembiso zayo. Uninzi lwemizi efumene iimpembelelo zemigodi zibe zezimbi kuphela kwimekobume yayo eyingqongileyo, yaye ayifumananga naziphina iinzozo. Izikhalo zemizi yemigodi nabasebenzi zidla ngokungakhathalelwu apho bekulindelwe ukuba zibe zezingundoqo kwinkqubo ye-SLP ukuze isebeenze kakuhle.

Injongo yesi siXhobo sokuSebenza (i-Toolkit) kukunika amalungu omzi nabasebenzi bomgodi ulwazi oluthile olusebenzayeo lwendlela esebeenza ngayo inkqubo ye-SLP, kwakunye namanyathelo athile okulandelwa ukuqinisekisa ukuba bayabandakanyeka yaye bayazuza kwinkqubo. Kumaphepha alandelayo, uya kufumana imizekelo ethile yemiyilo okanye yeemeko onokudibana nazo xa ujongene nemigodi kummandla wakho. Emva koko, uya kubona iziHlomelo ezintandathu ekubhekiswa kuzo kwisiXhobo sokuSebenza (kwi-Toolkit).

IsiHlomelo A sinikela ngoluhlu lwemibuzzo enokubakhona yokubuza kwiindibano zokubonisana zokuqala zomzi ukuze ubenakho ukubuza abameli benkampani yomgodi ngqo malunga noyilo lwe-SLP yabo nendlela iya kuba yinzozo kumzi. IsiHlomelo B siqulathe iiseti ezimbini zeefomu zokucela ufilelelo kwirekhodi (efana ne-SLP) evela nokuba kwiSebe le-Department of Mineral Resources okanye kwinkampani yomgodi ngokwayo. IsiHlomelo C sinikela ngoluhlu lokuhlola ongalisebenzisa xa uhlahlela uyilo lwe-SLP. IsiHlomelo D luluhlu lokulandela umkhondo wokuthobelwa komgodi iitekeni zawo ze-SLP. IsiHlomelo E siqulathe iinkcukacha zoqhagamshelwano lweofisi ezingundoqo zikarhulumente, amaziko ka-Chapter 9, amaggwetha anomdla kwiindaba zoluntu kwakunye neenkampani zemigodi onokuziswela. Okokugqibela, IsiHlomelo F sinikela ngesampulu yeencwadi ezimbini ongazisebenzisa ukuvandlakanya iincwadi zesikhala zoqhagamshelwano lweofisi ezingundoqo zikarhulumente.
